## Applying for Protected Voter Registration Information

*Data requests are fulfilled pursuant to*

*Elections Code §§ 2187, 2188, 2188.5(a), 2194 and Government Code § 7924.005*

### Qualifications

Voter registration information is available to persons or groups for election, scholarly, journalistic, political, or governmental purposes as described by the Secretary of State. Driver's license numbers, social security numbers, and voters' signatures cannot be released. Commercial use of voter registration information is prohibited.

All requests to view, purchase, or use voter registration information must be accompanied by a written application and a copy of the applicant's driver's license or state-issued identification card.

### Processing Time

Requests will be processed in the order in which the application *and* when payment in full is received. Once the application and payment is received, applications can take **2-3 business days** to process.

### Additional Prohibitions and Requirements.

The authorized recipients of the voter registration information are responsible for the security of all data provided through this request. The recipient may not leave the data unsecured or publicly available, physically or online. The data may not be transferred or shared outside the United States.

### Penalties

Violation of the requirements in the above-referenced Elections Code constitutes a misdemeanor subject to imprisonment and significant fines.

Every person who directly or indirectly obtains voter registration information shall be liable to the State of California for an amount equal to the sum of 50 cents multiplied by the number of registration records used in an unauthorized manner. This sum is in addition to the penalties arising from the misdemeanor.

### Formats

The requested data will be provided electronically in the form of plain text, tab-delimited files. The data will be transmitted via a secure file transfer server or on secure media such as a USB drive or CD.

### Other Data Sets

Other data sets, such as the Precinct-District File and Maps, are available; however, they do not contain confidential information and do not require the same qualifications as voter data. There is a separate form to obtain non-confidential information.

## Securing Voter Registration Information

### 2 CCR §§ 19102-19103



#### § 19012. Requirements for Storage and Security of Voter Registration Information.

(a) Any person who has directly or indirectly obtained voter registration information from a source agency must exercise due diligence in maintaining and securing the voter registration information in order to reduce the risk of information exposure and/or breach.

(b) Any person who has directly or indirectly obtained voter registration information from a source agency shall:

- (1) Use a strong and unique password ("strong password hygiene") per account with access to the voter registration information or privileges to grant access.
- (2) Apply security best practices, which includes the following: (A) Obtain training on security awareness to avoid social engineering and phishing attacks. (B) Practice the principles of "least privilege" By restricting user access to the minimum need based on users' job necessity. (C) Ensure user accounts are logged off or the session is locked after a period of inactivity, which shall be no more than 15 minutes. (D) Remove, deactivate, or disable accounts or default credentials. (E) Erase or wipe voter registration information that is no longer needed for its retention and sanitized following National Institute of Standards and Technology (NIST) 800-88 Guidelines for media sanitization. (F) Restrict physical access by not leaving your computer in places unlocked and unattended. (G) Limit the use of portable devices. If a portable device is used, strong storage encryption procedures must be applied utilizing Federal Information Processing Standards (FIPS) 197, commonly referred to as "Advanced Encryption Standard" or "AES." (H) Use wireless technology securely with Wi-Fi Protected Access 2 (WPA2) or better.

(c) In addition to the requirements set forth in (b) above, any vendor shall:

- (1) Apply additional security best practices, which include the following: (A) Use strong identity and access management, preferring multi-factor authentication for any and all privilege accounts and/or accounts with access to voter registration data. (B) Initiate an account lockout after a pre-defined number of failed attempts, no more than 10. Any automated account unlock actions must wait no less than 30 minutes from the lockout event. (C) Force password changes on a pre-defined basis, but not less than 365 days. (D) Backups of voter registration information shall be securely stored separately and utilizing FIPS 197 encryption at rest.

- (2) Implement security log management, which includes the following: (A) Enable logging on all systems and network devices with sufficient information collection that answers the following: (i) What activity was performed? (ii) Who or what performed the activity, including where or on what system the activity was performed? (iii) What activity was the action performed on? (iv) What tool(s) were used to perform or performed the activity? (v) What was the status, outcome, or results of the activity? (B) Review log(s) regularly for any errors, abnormal activities and any system configuration changes. (C) Securely store log files separately from the systems monitored, archived, and protect from unauthorized modification, access, or destruction. (D) Use log monitoring tools to send real-time alerts and notifications. (E) Utilize multiple synchronized United States-based time sources.

- (3) Employ system hardening techniques, which include the following:

- (A) Update and install all firmware and patches from a trusted and verifiable source. (B) Use only the most up-to-date and certified version of vendor software. (C) Install and maintain active malware and anti-virus software. (D) Implement firewalls, also known as host-based firewalls, and/or port filtering tools with host-based intrusion protection services. (E) Encrypt voter registration information using FIPS 197 at rest. (F) Encrypt voter registration information in transit such as Transport Layer Security (TLS) 1.2 or better with a valid certificate and certificate chain. (G) Do not use self-signed certificates. (H) Conduct regular vulnerability scanning and testing for known or unknown weaknesses. (I) Use application whitelisting on all endpoints and systems.

#### § 19013. Reporting Requirement for Unauthorized Use and Data Breaches.

Any person who has obtained voter registration information from a source agency shall report detected unauthorized use, suspected breach, or denial of service attack on the voter registration information or the system containing the voter registration information to the Secretary of State Elections Division Help Desk within twenty-four (24) hours of discovery.

### DATA FORMATS – A PRIMER

#### ELECTRONIC FILES (.txt) **\$130 per file**

The Voter Information FILE lists active voters with name, residence and mailing addresses, party, date of birth, email and phone numbers (if available) and districts of residence (Congress, State Senate, State Assembly, Supervisorial District, and city, if any). By law, the file cannot contain the voter's language preference.

By default, the file includes voting history for the last 5 statewide elections. Use the "FILTERS" section to specify other elections. A voter file request that includes all vote history for the voters requires two separate files, at no additional charge. The "VoterID" is the key field to join the two tables.

The Vote-by-Mail FILE contains the voters mailed a VBM ballot in the current election. The file contains dates the voted ballots were received by the election office, if applicable. The "Voter Data File Formats" document provides more information about the codes in those files.

#### ADDRESS LABELS **\$60 set-up fee, and the labels cost \$20 per 1,000 labels. (\$0.02 per label)**

Adhesive labels with voter addresses. Either one label for each voter, or one label for each household. Select a district. You may filter by party and/or whether the voter participated in specific elections. For household labels, voters with two different last names at an address generate two labels.

#### PRINTED VOTER LIST **\$0.50 per 1,000 voters.**

The voter list shows the voter's name, address, political party (or no party), date of birth, email (if provided by the voter), and your choice of phone number (if provided by the voter) OR voting history. Select a district. You may filter by party and/or whether the voter participated in specific elections. "The Voter List" is in order by street name and house number for the entire district.

Sometimes used for phone banking.

"The Walking List" is sorted by precinct, then street name, then street number.

Designed for door-to-door voter contact.
